## **AFFIDAVIT OF CATHIE GOWRYLUK**

I, CATHIE GOWRYLUK, of the Town of Oakbank, in the Province of Manitoba,

#### AFFIRM AND SAY THAT:

- 1. I am the former manager of Oak's Plaza, a strip mall located in Oakbank, Manitoba ("Oak's Plaza") and owned by The Oaks Limited Partnership (the "Partnership"), and, as such, I have personal knowledge of the facts and matters hereinafter deposed to by me, except where same are stated to be based upon information and belief, in which case I do verily believe them to be true.
- 2. I have read the Affidavit of Collin LeGall affirmed February 10, 2022 (the "LeGall Affidavit").

### <u>Background</u>

- 3. Between the years of 2014 and 2018, I was the manager of Oak's Plaza. During that period of time, my employer was K-Stone Construction Inc. ("K-Stone"), which is the general partner of The Oaks Limited Partnership, as explained in greater detail in the LeGall Affidavit.
- 4. Until on or about July 7, 2021, the sole director and officer of K-Stone was Micheal Handler ("Mr. Handler"). On or about July 7, 2021, Susan Deluca became the Secretary of K-Stone. Mr. Handler, meanwhile, remains as President and the sole director of the corporation. Attached hereto and marked as Exhibit "A" is a copy of a Notice of Change of Officers filed with the Companies Office on July 7, 2021.
- 5. As part of my former role as manager of Oak's Plaza, I looked after most administrative matters concerning the Partnership, including sending correspondence to the Partnership's 25 limited partners (the "Limited Partners"), as necessary, from time to time.
- 6. In or around 2018, Schinkel Properties took over the day-to-day management of Oak's Plaza. Concurrently, I was transitioned to work for Crystal Lake Development Ltd., of which Mr. Handler is an officer and

director. Since 2018, my salary has been paid by Crystal Lake Development Ltd., where I am employed as an office assistant.

7. Since the time that Schinkel Properties took over the day-to-day management of Oak's Plaza, I have continued to look after most administrative matters concerning the Partnership (namely, everything with the exception of accounting, which is handled by BDO Canada LLP). My longstanding role in that regard was not assumed by Schinkel Properties when it became property manager of Oak's Plaza.

## My Previous Correspondence with the Limited Partners

8. Since 2014, I have sent correspondence by mail to each of the Limited Partners from time to time. In particular, in consultation with Lori L. Ricard of BDO Canada LLP ("Ms. Ricard"), accountant to the Partnership, I sent dividend cheques (issued from the Partnership's bank account) to each of the Limited Partners, on occasion, as dividends were declared. In a few instances, the dividend cheques that I sent to certain of the Limited Partners went uncashed, and the associated payments had to be reversed and reallocated to the accounts of the corresponding Limited Partners. Attached hereto and marked as Exhibit "B" is a list of

the Limited Partners and the mailing address that I had on file for each of them as of June 2021.

- 9. Although I would send correspondence to the Limited Partners from time to time, as noted above, I never received anything in response from the Limited Partners, with a few exceptions, as described in greater detail hereafter.
- 10. On May 11, 2016, I received an email from Virginia Lok, who identified herself as the daughter of Shan Lok, one of the Limited Partners. Attached to Virginia Lok's email was a letter from Shan Lok to the Partnership dated May 10, 2016, wherein Shan Lok advised of a change of address, and made certain requests with respect to the payment of dividends and a transfer of interest in the Partnership. An individual by the name of "Vickey Lok" was copied on Virginia Lok's email, using the email address "topmac@netvigator.com" (I note that this is the same email address that is indicated at the top of Shan Lok's letter dated May 10, 2016). Shan Lok's requested transfer of interest was not ultimately pursued or completed. Attached hereto and marked as **Exhibit** "C" is Virginia Lok's email of May 11, 2016, together with Shan Lok's letter dated May 10, 2016.

- 11. In January 2018, I received an email from Andy Chen, who identified himself as the son of Tsu-Fen Chen, one of the Limited Partners. Andy Chen advised in the said email that his father, Tsu-Fen Chen, passed away on April 10, 2017, and he requested that Tsu-Fen Chen's interest in the Partnership be transferred to his surviving spouse, Liu Ching-Ping Chen. The requested transfer of interest was not subsequently recorded in the records of the Partnership. Attached hereto and marked as **Exhibit "D"** is a chain of emails exchanged between Andy Chen, Mr. Handler and me in January 2018.
- 12. In May 2019, I received an email from a woman by the name of "Phyllis", who identified herself as a family member of Terence Lo, one of the Limited Partners. Phyllis advised in the said email that Terence Lo was interested in selling his interest in the Partnership, and that he wanted to know the price at which he could do so. The requested sale of Terence Lo's interest in the Partnership did not ultimately proceed. Attached hereto and marked collectively as **Exhibit "E"** are the emails that were exchanged between Phyllis, Mr. Handler and me between May 2019 and January 2020.

# My Recent Attempts to Contact the Limited Partners

- 13. On June 28 and 29, 2021, at the request of Collin LeGall, a Licensed Insolvency Trustee with Lazer Grant Inc. ("Mr. LeGall"), I sent a letter with two enclosures to each of the Limited Partners, to the most recent addresses available in the records of the Partnership. Attached hereto and marked collectively as Exhibit "F" are copies of the 25 letters that I sent to the Limited Partners at Mr. LeGall's request, as aforesaid.
- 14. Enclosed with each of the 25 letters that I sent to the Limited Partners were two documents, namely: (i) a form entitled "Approval by Limited Partner of The Oaks Limited Partnership" (the "Approval Form"); and (ii) a one-page excerpt (page 24) from the Partnership Agreement pertaining to the Partnership (the "Partnership Agreement Excerpt"). Attached hereto and marked collectively as Exhibit "G" are copies of the Approval Form and the Partnership Agreement Excerpt.
- 15. Of the 25 letters the I sent to the Limited Partners:
  - (a) six were sent via Canada Post Xpresspost to international addresses (the "Overseas Letters"); and

- (b) 19 were sent via registered mail with Canada Post to Canadian addresses (the "Domestic Letters").
- 16. Each of the International Letters was successfully delivered to the intended recipients in early July 2021.

### 17. Of the Domestic Letters:

- (a) four were returned to K-Stone's office in Oakbank, Manitoba as "Unclaimed" (namely, those addressed to Kuen Wah Ng, Shui Sang Wong, Sek Lei Chau and Sie Wie Cheung); and
- (b) 15 were successfully delivered.
- 18. However, one of the 15 Domestic Letters that was successfully delivered (namely, the letter addressed to Shao Tang Ho) was subsequently returned to K-Stone's office, with the address on the envelope having been crossed out in pen, and the word "Moved" written on it.
- 19. Attached hereto and marked as **Exhibits "H"** and **"I"**, respectively, are the following:

- (a) tracking details for each of the International Letters and Domestic Letters, which I obtained from the Canada Post website on October 28, 2021 (Exhibit "H"); and
- (b) photocopies of the five envelopes that were returned to K-Stone's office (Exhibit "I").
- 20. I note that on page 3 of Exhibit "H", the first two entries read "Item available for pickup at Post Office." I initially believed that this meant that the letters in question were available for pickup by the addressees at a Post Office nearest to their respective residences. However, in early November 2021, after downloading the attached tracking details from the Canada Post website, I realized that the two letters in question were in fact available for pickup by me at the Post Office in Oakbank, as they had been returned unclaimed (these are two of the four unclaimed letters that I reference above in paragraph 17). On November 2, 2021, I retrieved the two letters in question from the Post Office in Oakbank.
- 21. I have caused for the five envelopes that were returned to K-Stone's office to be sent to Mr. LeGall.

22. The Partnership has email addresses associated with only a small number of the Limited Partners, the particulars of which are as follows:

23. On January 6, 2022, I sent an email to the addresses associated with each of the following individuals, as listed in the table above (paragraph 22): (i) Hon Wing (Jon) Lok; (ii) Shan Lok; (iii) Tsu-Fen Chen; (iv) Terence Lo; and (v) Ju-Tien Chen. Attached to each of the emails was a copy of the corresponding letter that I sent to the Limited Partners in late June 2021. In each of the emails, I asked that the recipient

confirm that the letter was received by mail. I requested a "Read" receipt for each of the emails, but none of the recipients returned one. I did not request "Delivery" receipts, as I was unsure how to do so using my email provider (MTS). Attached hereto and marked collectively as **Exhibit "J"** are copies of the emails that I sent on January 6, 2022.

- 24. I note that, in my January 6, 2022 email to Shan Lok, I incorrectly inputted the address "topmac@netvigator.com". On January 7, 2022, upon receiving an undeliverable notification in response to the aforementioned email, I re-sent the email to the correct address. Attached hereto and marked as **Exhibit "K"** is a copy of my January 7, 2022 email to "topmac@netvigator.com".
- 25. I only received one response to the aforementioned emails that I sent on January 6 and 7, 2022. Namely, on January 24, 2022, I received an email from Ju-Tien Chen (ardin\_c@yahoo.com), who advised of a change of address. On January 25, 2022, I responded to Ju-Tien Chen by email, wherein I requested confirmation that the letter that I sent in late June 2021 had been received. On January 27, 2022, at Ju-Tien Chen's request, I sent a copy of the June 11, 2021 letter and its enclosure to Ju-Tien Chen by email. Attached hereto and marked


collectively as Exhibit "L" are copies of the emails that I exchanged with Ju-Tien Chen on January 24 - 27, 2022.

#### V. DISSOLUTION

- 1. The Partnership shall be dissolved on the first to occur of the following:
  - (a) the dissolution, bankruptcy or assignment for the benefit of creditors of the General Partner; or
  - (b) 90 days following the end of a three year period (hereinafter called the "Holding Period") which period begins to run from the time the monies are transferred to the Partnership from the escrow agent who held the funds in escrow for the Limited Partners.

Subject where applicable to compliance with the provisions of The Partnership Act and for the renewal thereof, the Partnership shall not dissolve or terminate on the death, bankruptcy, assignment of property in trust for the benefit of creditors, or adjudication of incompetency or insanity, legal incapacity, withdrawal or attempted withdrawal, of or by any Limited Partner, or the admission of any additional or substituted Limited Partners.

- 2.
